1. **Fee**

Registration Fee is currently £222.00.

Registration means that you are registered with the Environmental Health Registration Board (EHRB) and will receive your Certificate of Registration once you have successfully completed your academic course and all of the required assessments.

You will also need to pay the appropriate assessment or examination fees when you apply for them.

We do not issue invoices for Registration fees. However, we will send you a receipt for your fee when we have processed your application and your payment has cleared.

2. What happens next?

Once we have received your completed form and processed your payment we will register you and enter your details on the Student Database. We will send you a letter confirming your Student Registration number and giving you further information.
